SUPPORTIVE, AFFORDABLE HOUSING: SUCCESS BEGINS WITH A HOME AND THEREFORE COMMUNITY HOUSING PARTNERSHIP OPERATES ON A HOUSING FIRST MODEL. COMMUNITY HOUSING PARTNERSHIP PROVIDES CLIENTS SAFE, AFFORDABLE HOUSING WITH ONSITE PROPERTY MANAGEMENT. COMMUNITY HOUSING PARTNERSHIP OWNS, MANAGES, AND/OR PROVIDES SERVICES AT 16 BUILDINGS THROUGHOUT SAN FRANCISCO, COMPRISING OVER 1,100 UNITS AND HAS 303 UNITS IN DEVELOPMENT. COMMUNITY HOUSING PARTNERSHIP'S HOUSING AND SERVICES PORTFOLIO ANNUALLY IMPACTS THE LIVES OF OVER 1,500 FORMERLY HOMELESS ADULTS, SENIORS, TRANSITIONAL-AGE YOUTH AND FAMILIES. INTENSIVE WRAPAROUND ON-SITE SERVICES: COMMUNITY HOUSING PARTNERSHIP OFFERS A DIVERSE CONTINUUM OF WRAPAROUND SUPPORT SERVICES FOR ITS CLIENTS. THESE SERVICES ASSIST CLIENTS STABILIZE WITHIN A SERVICE-ENRICHED HOUSING SETTING, WHILE RECONNECTING WITH THEIR LIFE GOALS SUCH AS EDUCATION, EMPLOYMENT, AND CIVIC ENGAGEMENT. OBTAINING STABLE, SAFE HOUSING IS A LONG AND COMPLICATED PROCESS FOR MANY CLIENTS AND ALTHOUGH THEY ARE EXCITED FOR THIS NEW CHAPTER, THE TRANSITION IS OFTEN MORE OVERWHELMING THAN EXPECTED AFTER HISTORIES OF CHRONIC HOMELESSNESS, COUPLED WITH CO-OCCURRING MENTAL HEALTH ISSUES, SUBSTANCE ABUSE, PHYSICAL DISABILITIES, AND CRIMINAL JUSTICE AND/OR FOSTER YOUTH SYSTEM INVOLVEMENT. MANY CLIENTS SUFFER FROM POST-TRAUMATIC STRESS DISORDER AS A RESULT OF THESE HISTORIES AND SYMPTOMS WILL LIKELY NOT
